1. **Rules:** The regatta will be governed by the 2013-2016 Racing Rules of Sailing.

2. **Eligibility and Entry:**

- 2.1 The regatta is open to all Lightnings with a valid measurement certificate issued by the ILCA.
- 2.2 This is a Southern Lightning District (SLED) Circuit Qualifier event.
- 2.3 Eligible boats may enter by paying the fees and completing the Entry Form, which is attached and will be available at registration.
- 2.4 Registration is complete when CYC has received your Entry Form and Entry Fee.
